

Student Safety Video Award

Official Rules & Submission Policy

Purpose

The Student Safety Video Award recognizes Alaska middle and high school students and school staff who promote workplace safety through creative, accurate, and impactful video submissions. The award supports school-based learning and encourages youth engagement in workplace safety and health.

Eligibility

- Students actively enrolled in an Alaska middle school or high school, including home-school programs, are eligible to participate.
- All participating students must be enrolled at the submitting school.
- Submissions must be created by a school-associated group (class, club, team, or program), or created by individual student(s) with a teacher or staff sponsor.
- Each submission must include a school-affiliated teacher or staff sponsor, who serves as the official submitter.
- School staff may appear on camera; however, videos must be written/scripted, filmed, produced, and edited by students.
- Submissions without a verified school sponsor are not eligible.

Submission Limits

- Only one entry per group or individual.
- Multiple submissions per school are permitted.

Participant Identification & Recognition

- The winner(s) will be recognized at the 2027 Alaska Governor's Safety and Health Conference Awards lunch.
- All participants must be listed by name on the official submission form.
- Only individuals listed on the submission form will be included in certificates, public recognition, award materials, and announcements.

Submission Standards

- Videos must be original work created by the listed student participants.
- Videos must be one (1) minute or less in length.
- Videos must focus on one approved workplace safety topic.
- Videos must be appropriate for a high school audience.
- All individuals appearing in the video must have provided permission to be recorded.
- Parental or guardian consent is required for students under 18.
- Use of copyrighted music, images, or video without permission is not permitted.

2027 Approved Safety Topics

- Fall Protection
- Hazard Communication
- Personal Protective Equipment (PPE)
- Young Worker Safety in Restaurants

Judging & Awards

Submissions are evaluated by a selection committee using established criteria, which may include:

- Accuracy and clarity of the safety message
- Creativity and engagement
- Relevance to young workers
- Overall effectiveness

The committee reserves the right not to present an award if submissions do not meet minimum standards. Committee decisions are final.

Each student listed on the submission form of the winning entry will receive a certificate of recognition. The cash prize for the winning entry will be issued to the sponsoring school or home school program.

Use of Awarded Videos

By submitting a video, participants grant permission for submissions to be used by the Alaska Governor's Safety and Health Conference and partner organizations for educational and training purposes, conference presentations, promotion of workplace safety initiatives, and promotion of the Governor's Safety and Health Conference. Videos may be edited for length or format as needed. Attribution will be provided where practicable.

Compliance

Failure to meet eligibility, sponsorship, or submission requirements may result in disqualification.
